### **Summary of 2024H1 Operating Results**

- Net sales was NT\$ 774 million.
- Gross profit was NT\$ 372 million with 48.09% gross margin.
- Operating income was NT\$ 265 million with 34.23% operating margin.
- Net income was NT\$ 258 million.
- EPS was NT\$ 4.50; Book Value per share was NT\$ 22.52.

#### **Net Sales**

The Company announced 2024H1 net sales of NT\$ 774 million, an increase of 37.98% year-over-year.

#### **Gross Profit and Gross Margin**

• Gross profit and Gross margin for 2024H1 was NT\$ 372 million and 48.09%, respectively. Gross profit was increased 75.36% year-over-year.

#### **Operating Income and Operating Margin**

• Operating income and Operating margin for 2024H1 was NT\$ 265 million and 34.23%. Operating income was increased of 104.51% year-over-year.

#### **Net Income and EPS**

- Net loss after tax was NT\$ 258 million.
- EPS was NT\$4.50. For 2024H1, the book value was NT\$22.52 per share.
